## PROGRAM OVERVIEW & REGISTRATION

The New Jersey Department of Community Affairs, the New Jersey Division of Fire Safety, and the National Fire Academy announce the New Jersey State Weekend Program at the National Fire Academy. This year's attendees will have the opportunity to choose between nine (9) two-day courses. The courses are open to the target audience of Fire, EMS, Company and Chief Level Officers.

This program is cost-shared between the participant and the National Fire Academy. The National Fire Academy provides housing, classrooms, faculty and materials at no cost. The fee paid by the applicant covers three (3) meals on Saturday and two (2) on Sunday for the cost of \$84.30. You also have the option to purchase a Weekend Meal Ticket if you plan on purchasing a meal on Friday night 11/28/2022 which includes Friday night (April 28th) dinner through Sunday (April 30th) meals is available for \$105.76. **The deadline for receipt of the 2023 New Jersey Weekend application is March 17, 2023.**

If you are attending this program and are only interested in meals for Saturday (breakfast, lunch & dinner ) and Sunday (breakfast & lunch), you must mail a check in the amount of \$84.30, made payable to "Kean University"; a completed application with FEMA form (General Admissions Application) and application on page 15.

If you are attending this program and prefer to purchase a Weekend Meal Ticket (Friday night dinner, Saturday (breakfast, lunch and dinner and Sunday (breakfast and lunch) you must mail a check in the amount of \$105.76, made payable to "Kean University"; a completed application with FEMA form (General Admissions Application) and application on page 15 with the desired food choice plan selected.

A separate check must be included with each application. NO VOUCHERS OR PURCHASE ORDERS WILL BE ACCEPTED. ## HOMELAND SECURITY/FEMA SID NUMBER (REQUIRED FOR PARTICIPATION)

New administrative procedures implemented by the U.S. Department of Homeland Security/FEMA require that all students must obtain a FEMA Student Identification (SID) Number to attend any courses on campus, or receive credit through State delivery systems. The purpose is to remove the Social Security Number from their computer systems to safeguard sensitive data from being hacked within the Federal computer systems.

Students will need to obtain this number prior to submitting their 2023 NJ Weekend application to Kean University. This requirement will be enforced by DFS upon all who attend the NJ Weekend, and on all outreach program deliveries conducted in New Jersey. Failure to place the FEMA student ID number on the General Admissions Application will result in your application being returned, no exceptions will be made.

Once a student has received their FEMA Student Identification (SID) Number it becomes their permanent identification number for all National Fire Academy programs. Please visit <https://cdp.dhs.gov/femasid/> to request a ID# or to retrieve an existing ID#. After completing the FEMA (General Admissions Application) form, please print and have your Fire Chief or Agency Head indicate his or her approval and confirmation that the applicant has met course selection

criteria and prerequisites by signing on line 22a. We recommend that on line 9a of the application you indicate three courses of interest to you, since we cannot guarantee your first course selection. Example: (1) W0322 (2) W0457 (3) W0522. **The New Jersey Division of Fire Safety reserves the right to place an applicant into any course delivered regardless of the course preferences.**

Do not enter course numbers for classes that you are not willing to attend. If you previously completed one of the listed courses, you may not attend it again.

## **APPLICATION DEADLINE**

The last date for receipt of postmarked applications is **March 17, 2023**. No applications will be accepted after this deadline. Telephone reservation requests or faxed applications are not accepted. Applications that are incomplete or do not have the proper form of payment will be returned and must be resubmitted. Applicants will receive notice of application receipt via email. All correspondence will be via email so it is the responsibility of the applicant to provide a correct email address in order to receive such correspondence. **THE LAST DAY TO CANCEL REGISTRATION AND RECEIVE A REFUND IS MARCH 31, 2023.** Substitution of an applicant will not be permitted when someone withdraws.

## **ADMISSION CRITERIA**

Applications will be considered on a first-come, first-served basis, provided the applicant has a minimum of three years' experience as a first responder and meets the National Fire Academy Student Selection Criteria listed for the course selected. The National Fire Academy can only provide accommodations for qualified students. Therefore, in order to diversify the group of attendees at this event, the New Jersey Division of Fire Safety requests that no more than six individuals from any one organization submit an application. No more than two members from the same fire department will be permitted into the same class. Acceptance notices will be emailed. It is the responsibility of the applicant to provide a correct email address in order to receive correspondence.

## **PROFESSIONAL CONDUCT**

Each individual has the personal responsibility to exhibit professional conduct while on the National Fire Academy campus and in the neighboring community. The New Jersey Division of Fire Safety has the responsibility and authority to monitor, and along with campus security, to take necessary action to correct unprofessional conduct. Any person that has sanctions taken against them will be reported to their agency chief. Serious infractions will cause the attendee to be sent home immediately and will result in the individual being banned from attending the New Jersey Weekend for two (2) years.

**If you submitted an application for New Jersey Weekend and cannot attend, you must notify Kean University at 908-737-3069 or via e-mail at [dkierych@kean.edu](mailto:dkierych@kean.edu). Failure to do so will result in you being banned from attending NFA courses for two years. The only exception to this policy will be cases of emergency which must be coordinated through New Jersey Weekend staff.**



## CHECK-IN

---

Registration takes place on April 28, 2023 beginning at 4:00 p.m., in the lobby of Building C. Upon arrival, you must report to the National Fire Academy's check-in desk to obtain room assignments, key card, your meal ticket, and a name tag, which must be kept with you at all times. Photo identification is required to be admitted through the main gate of the NFA and to be admitted to check-in at the guest service table for registration. If you drove a vehicle, you will be required to submit your vehicle's tag number and park in the assigned parking lot. Security personnel at the gate may search your bag, car or clothing. In order to avoid a delay in the registration process, please have this information readily available. You must also register at the New Jersey Division of Fire Safety's table in the lobby of Building C.

## ROOM ASSIGNMENTS

---

All lodging rooms are non-smoking and are randomly assigned by the National Fire Academy Admissions Office. Due to the random assignments of rooms, classmates may not be lodged together. Students may be lodged a distance from the registration building; for this reason we recommend luggage with wheels. The exchanging of rooms is not permitted. The reason for this is to maintain accountability. Dormitory Room Amenities include twin bed, linens, towels, private bathroom, TV and clock radio, refrigerator and telephone with voice mail.

## CAMPUS SECURITY REGULATIONS

---

The NFA is a federal facility. Due to increased security precautions, students should bring two photo identifications to campus. Please have them with you; not in your luggage. **If you do not have the photo ID's, you will not be permitted on campus.** Due to heightened security requirements, security and law enforcement personnel may search you, your vehicle or your luggage. Alcohol is not allowed in lodging rooms or vehicles and will be confiscated. For your own protection, and to expedite your processing into the National Emergency Training Center, do not bring weapons of any kind to campus. Maryland law is very narrow in its definition of Law Enforcement Officers who may carry firearms.

## PARKING

---

Participants must register their vehicle with the National Fire Academy upon arrival at 'C' Building, so have your license tag number with you, when you register. The National Fire Academy's staff will direct you on where you may park your vehicle. Please do not park in faculty/staff parking areas or other restricted zones. Refer to the campus map, which is available at the National Fire Academy's registration desk. The payment of parking tickets received is the sole responsibility of the student.

## NFA TELEPHONE NUMBERS

If you need to be contacted while at the NFA, you may use the incoming campus telephone number 301-447-1048 for messages. The number is operational 24 hours a day.

## **DRESS CODE**

It is each student's responsibility to use good judgment in selecting attire that projects a professional image and that is appropriate for both climate differences and classroom activities. The staff of the New Jersey Division of Fire Safety and the National Fire Academy will determine if a student's attire is inappropriate. Students whose attire is determined to be inappropriate will be required to change into more appropriate clothing before being allowed to participate in class. Shorts, sleeveless shirts, ball caps, open-toe sandals, thongs, etc., are not permitted in classrooms, the auditorium, or the dining hall. Shorts, t-shirts and athletic attire may be worn after classes have been completed for the day. Bathing suits/trunks are not permitted outside the pool area.

## **ACCEPTABLE ATTIRE FOR CLASSROOM SETTINGS**

Males: Shirts with collars (T-shirts, including departmental T-shirts are not acceptable), slacks, nice jeans, departmental uniforms, shoes and socks.

Females: Dresses, blouses, (T-shirts including departmental T-shirts are not acceptable), slacks, capris, nice jeans, skirts, skorts; departmental uniforms, and shoes. Dresses, skirts/skorts should be no higher than one inch above the knee (no miniskirts).

## **NEW JERSEY'S TWO-DAY PROGRAM**

The New Jersey Two-Day Program is provided by the National Fire Academy to allow attendance at the Emmitsburg, Maryland campus for students who cannot attend the one or two week residential programs. While on campus for this program, students should take advantage of the facilities and the various resources that are available to them.

## **LEARNING RESOURCE CENTER, BUILDING N**

The Learning Resource Center (LRC) provides current information and resources on fire and emergency management subjects. ## **DINING HALL AND LOG CABIN**

Use your meal ticket on Saturday and Sunday to have breakfast and lunch in the on-campus dining hall. Meals are provided buffet style during the following times: Breakfast: 6:45 a.m. - 9:30 a.m., Lunch: 11:30 a.m. - 1:00 p.m. and Saturday evening's meal: 6:00 p.m. at the log cabin or student center. The log cabin overlooks peaceful Tom's Creek.



## The National Firefighters Memorial

Conceived as a tribute to America's fire service, the National Fallen Firefighters Memorial is one of this country's most beautiful monuments to courage and unselfish service. Constructed in 1981 on the campus of the National Fire Academy in Emmitsburg, Maryland, the Memorial was officially designated by Congress as the National Memorial to career and volunteer fallen firefighters in 1990. It is a symbol of honor for those who carry on the tradition of service to their communities.

## New Jersey Memorial Service

On Saturday, April 29, 2023 after courses have concluded for the day, the Division of Fire Safety invites the students attending the NJ Weekend to gather in front of the The National Firefighters Memorial (weather permitting) to honor those New Jersey firefighters who have died in the line of duty in 2022. There will be a brief service which includes the identification of the firefighters and ringing of the ceremonial bell. The service is expected to last approximately 20 minutes.

\* Students are not required to wear their class A uniforms. Normal classroom dress attire is acceptable.



## **ATHLETIC FACILITIES BUILDING H**

---

After classes, a fully equipped gymnasium, weight room, and an indoor swimming pool are available for your use at the Athletic Facility Building. The exercise room and swimming pool hours are: Friday evening: 4:00 p.m. - 8:30 p.m., Saturday and Sunday: 7:00 a.m. until 1:00 p.m., and Saturday evening: 3:30 p.m. - 8:00 p.m. Athletic equipment is available for check-out at this location. This includes softball, golf, basketball and volleyball equipment as well as bicycles and helmets. Bathing suits/trunks are not permitted outside the pool area.

## **STUDENT CENTER AND COMMAND POST PUB**

## **ELIGIBILITY TO ATTEND COURSES**

---

To take a National Fire Academy course, applicants must meet the selection criteria and prerequisites specified for each course. Disregard of the specified course requirements results in an audience mix that is difficult for the instructor, and leads to frustration on the part of those students who meet the target audience criteria. Participants may not take the same course at the National Fire Academy more than once.

## **CLASS ATTENDANCE AND CONDUCT**

---

You are to report to the class that is listed on the Confirmation Notice that was emailed to you by Kean University. Your assigned course is one of the three course selections that you identified on your application or has been assigned to you by the New Jersey Division of Fire Safety. The National Fire Academy's Program Manager prohibits you from switching classes because the rosters and course certificates are prepared in advance. If you have a valid reason for needing to switch classes, you must receive approval from the New Jersey Program Coordinator before the start of class on Saturday. In order to receive a Certificate from the National Fire Academy and Continuing Education Credits from the New Jersey Division of Fire Safety, you must attend and participate in the two-day class sessions from start of class until conclusion. The class schedules are: Saturday 8:00 a.m. - 5:00 p.m. and Sunday 8:00 a.m. - 3:00 p.m. Students, instructors, and staff are expected to treat each other with respect at all times. Inappropriate behavior will not be tolerated and may result in removal from campus. End of course exams must be passed with a score of 70% or higher to receive credit for each course delivery.

# Program Course Offerings

**Award of CEU's:** Each course delivered through the National Fire Academy (NFA) State Weekend is a two-day program of instruction and will receive from the NJ Division of Fire Safety 1.0 CEU's (Technical) towards renewal of a NJ State Fire Instructor certification. In addition, the following course codes will receive additional CEU's towards renewal of a Code Enforcement certification: W0522, W0602 and W0646.

**Attendance Criteria:** Student's must attend the full two-days of course instruction, and successfully complete assigned Prerequisite and Post-Course Requirements in order to receive credit. Where an exam is administered in a course, the student must obtain a grade of 70 or higher to pass the course.

### **Course Description and Selection Criteria**

This two-day course is designed to provide fire officers with an understanding of command operations at structural collapse incidents. Individuals who have statutory authority/responsibility and may serve in a Unified Command structure at a structural collapse; fire command officers.

### **Prerequisites**

Incident Command System (ICS)-100-level and ICS-200-level training. Preferred courses are Q0462 and Q0463, available through NFA Online. Chief's signature attests that the applicant has completed this required training.

### **Post-course requirements**

None



## DECISION-MAKING FOR INITIAL COMPANY OPERATIONS **W0457**

### **Course Description and Selection Criteria**

This two-day course is designed to develop the decision-making skills needed by Company Officers (COs) to accomplish assigned tactics at structure fires. All activities and scenarios used in this course are based on structure fires. With the real possibility of being the first to arrive at an incident, the CO's initial decisions will have an impact throughout the entire incident. It is vital that COs be able to make good management decisions that have a favorable impact on the eventual outcome.

In addition to a possible role as the initial Incident Commander, the CO may well be assigned a subordinate position within the Incident Command System organization. COs need to have a clear understanding of the system, the position that they are assigned to, and their role in the organization if they are to function effectively and help make the system work. This course is an excellent review for experienced CO's, or for newly appointed COs and for firefighters who may have acting CO responsibilities or who want to become a CO.

### **Prerequisites**

Incident Command System (ICS)-100-level and ICS-200-level training. Preferred courses are Q0462 and Q0463, available through NFA Online. Chief's signature attests that the applicant has completed this required training.

## EXECUTIVE SKILLS SERIES: EXERCISING LEADERSHIP THROUGH DIFFICULT CONVERSATIONS **W0522**

### Course Description and Selection Criteria

The primary target audience is fire and emergency service personnel in positions of authority (executive level officers) who have an opportunity to exercise leadership. The purpose of this two-day course is to provide knowledge and skills for having difficult conversations to exercise leadership in addressing adaptive challenges. The goal of this course is for the participant to identify and apply skills for having difficult conversations as they relate to exercising leadership when addressing adaptive challenges.

**Note:** Participants must be minimally assigned to a supervisory level position (for example, a Company Officer).

### Prerequisites

Incident Command System (ICS)-100-level and ICS-200-level training. Preferred courses are Q0462 and Q0463, available through NFA Online. Chief's signature attests that the applicant has completed this required training.

### Course Description and Selection Criteria

First- and second-level supervisors and COs who are upwardly mobile within their organizations and whose department head wishes to prepare them for increased managerial responsibility. Administrative officers who are responsible for significant staff functions within the organization and who report directly to top management. Emergency service workers assigned to positions with decision-making responsibilities.

### Prerequisites

Incident Command System (ICS)-100-level and ICS-200-level training. Preferred courses are Q0462 and Q0463, available through NFA Online. Chief's signature attests that the applicant has completed this required training.

**Course Description and Selection Criteria**

This two-day course is designed to provide Company Officers (COs) with a better understanding of multiagency needs and a Unified Command structure. The attendees will gain an understanding of the requirements of a Unified Command organization and provide learners with the knowledge and skills necessary to operate effectively in complex incidents. The primary audience for the course is fire department COs, first responders, chief officers, and others who would function in a Command or General Staff position during a multiagency operation. Further specification for the audience includes officers who have command responsibilities, are upwardly mobile and act in the position of a command officer, would function in a Command or General Staff position during a Unified Command operation, and are initially responsible for setting up the Incident Command organization.

**Selection Criteria**

First- and second-level supervisors and COs who are upwardly mobile within their organizations and whose department head wishes to prepare them for increased managerial responsibility. Administrative officers who are responsible for significant staff functions within the organization and who report directly to top management. Emergency service workers assigned to positions with decision-making responsibilities.

**Prerequisites**

Incident Command System (ICS)-100-level and ICS-200-level training. Preferred courses are Q0462 and Q0463, available through NFA Online. Chief's signature attests that the applicant has completed this required training.

## **YOUTH FIRESETTER INTERVENTION SPECIALIST** **W0633**

Youth Firesetter Intervention Specialist is a 2-day course based on the requirements of NFPA Standard 1035 pertaining to the Youth Firesetting Intervention Specialist. The course focuses on how identification, intake, screening, disposition, and follow-up are used to mitigate youth firesetting behavior. This course is for the practitioner who provides services at the program delivery level.

### **Selection criteria**

Students either have or will have responsibilities as the practitioner who provides services at the program delivery level. This includes the person who is responsible for the identification, intake, screening, educational intervention, follow-up, and evaluation of the program services and results. Students representing the fire service are encouraged to partner with other agencies for this training. Partners can include but are not limited to fire investigators, law enforcement, mental health, social services, juvenile justice, or other stakeholders who can assist in building and maintaining programs in their communities.

**Note:** There is a pre-course assignment students will need to bring to class. To achieve the optimal benefits of the course, we ask that you perform some basic research in advance of the course. Please come prepared to discuss the following information pertinent to your community:

- Is your community urban, suburban, rural or a mixture (per se)?
- How many youth firesetting (YFS) incidents does your organization handle per year?
- What types of YFS incidents do you handle the most frequently?
- Are there particular age groups that represent a greater problem than others?
- What is the minimum age at which your jurisdiction can file criminal charges against a youth for fire-related incidents?
- If charges can be filed, what is the average number of youth that are charged per year?
- On average, how many injuries caused by youth firesetting does your community experience per year? How many deaths?
- On average, how much property loss is associated with youth firesetting per year?

If your organization currently has a YFSPI program, please bring copies of the various documents that are utilized to support it, such as intake and screening forms. Please also bring a copy of any lesson plans for the educational component of your program. If your organization does not have a program, do not worry. The course includes many examples of support materials.

# LEADERSHIP IN SUPERVISION: CREATING ENVIRONMENTS FOR PROFESSIONAL GROWTH **W0646**

## **Course Description and Selection Criteria**

This two-day course presents the supervisor with the basic leadership skills and tools needed to perform effectively in the fire and EMS environment. The course includes concepts related to a successful transition to supervisory and leadership roles, including concepts of adaptive leadership; change management; active followership; effective communication, including difficult conversations and advocacy-inquiry based dialogue; ethics; authority; power; decision-making; and active engagement through development of a personal plan. The primary target audience for this course are those individuals who are at the first line level of supervision. For purposes of student selection first line level is considered to be those at the Company Officer or Unit (fire prevention, fire education, communications, EMS, etc.) Supervisor level.

## **More specifically primary selection criteria are as follows:**

- First line supervisors in fire and emergency medical services organizations.
- Fire and emergency medical services personnel due for promotion/appointment to a first line supervisory position within 18 months.
- Fire and emergency medical services personnel who are regularly assigned acting supervisory positions.

Fire and EMS personnel currently enrolled in the National Fire Academy Managing Officer Program will be provided priority selection.

The secondary target audiences are fire and EMS personnel at the first line management level (Chief Officer or above). Students at this level may be given consideration on a space available basis.

## **Prerequisites**
